Julie has successfully case managed clients with challenging behaviour and has drawn on personal life experience of learning disability and also paediatric disability to help her manage difficult situations with understanding and empathy.

As well as working with clients more local to her, Julie has experience of working with clients in remote parts of Cumbria and the Isle of Man and has developed a good working knowledge of services available in those areas.

Julie works closely with the treating therapists on all her cases, so she is familiar with advances in equipment and techniques.

Julie is skilled at tailoring her client's environment to support their rehabilitation and priorities, either through specialist facilities or promoting independence in their own home. Recently, she has supported families in securing rental accommodation to make home-based therapy possible and practical.

PREVIOUS EXPERIENCE

Prior to joining Rehab Without Walls, Julie set up treatment plans for residents in a specialist facility with varying degrees of organic brain disorders and associated cognitive and physical impairments. She monitored residents to identify problems such as challenging behaviour, developed programmes to resolve these problems and instructed and supported care workers to implement them.
