Through his previous roles, which ranged from social work practitioner to senior management within local authorities, Tony gained extensive experience working with vulnerable adults and children, including working with families with complex issues and needs, commissioning services and care packages, monitoring budgets and assessing and managing risk.

He managed a number of operational teams including learning disabilities, hospital and community social work and direct payments and was the department's social care lead for the drug and alcohol service.
